SUMMARY

The United States District Court for the Eastern District of Missouri addresses the assessment and collection of appellate filing fees following remand from the Eighth Circuit. The court assesses \$605 in appellate filing fees and orders Plaintiff Bryce Lanear to submit an updated certified prison account statement by March 20, 2026.

QUESTIONS PRESENTED

- Whether the district court should assess and collect the appellate filing fee after remand from the Eighth Circuit.

2. Whether Plaintiff must submit an updated certified copy of his prison account statement for the preceding six months to facilitate calculation and collection of the fee.

HOLDINGS

1. On remand, the district court assessed appellate filing fees of \$605 in the prisoner's civil action and directed Plaintiff to comply with the fee-collection procedure.
2. Plaintiff must file an updated certified copy of his prison account statement, or institutional equivalent, for the preceding six months no later than March 20, 2026.

FACTUAL BACKGROUND

Plaintiff is a prisoner who pursued an appeal in a civil action. The Eighth Circuit remanded the matter to the district court to calculate and collect the appellate filing fee under *Henderson v. Norris*.

PROCEDURAL HISTORY

After Plaintiff filed an appeal, the Eighth Circuit remanded the matter to the district court for assessment and collection of the appellate filing fee. The district court assessed \$605 in appellate filing fees and ordered Plaintiff to submit an updated certified six-month prison account statement by March 20, 2026.

DISPOSITION

REMAND INSTRUCTIONS

Plaintiff must file an updated certified copy of his prison account statement, or institutional equivalent, for the past six months by March 20, 2026, so that the appellate filing fee can be calculated and collected.

MEMORANDUM AND ORDER

This matter is before the Court on remand from the United States Court of Appeals for the Eighth Circuit for calculation and collection of the appellate filing fee pursuant to *Henderson v. Norris*, 129 F.3d 481 (8th Cir. 1997). ECF No. 59. Appellate filing fees in the amount of \$605 are assessed in this matter. See *Henderson*, 129 F.3d at 485 (“When a district court receives a prisoner’s notice of appeal in a prisoner’s civil action, it shall assess the . . . appellate filing fees and process the appeal in ordinary course.”). Pursuant to *Henderson*, no later than March 20, 2026, Plaintiff shall file an updated copy of his prison account statement (or institutional equivalent) for the past six months. See *Henderson*, 129 F.3d at 484 (outlining the process by which the assessed fees are calculated and collected). IT IS HEREBY ORDERED that no later than March 20, 2026, Plaintiff shall file an updated certified copy of his prison account statement (or institutional equivalent) for the past six months.
