Appeal of Aytekin Serol Insaat Taahhut Muhendislik Anonim Sirketi

SUMMARY

The Armed Services Board of Contract Appeals sustained the appeal of Aytekin Serol Insaat Taahhut Muhendislik Anonim Sirketi under a Department of Defense contract after the parties resolved their dispute. In the nature of a consent judgment, the Board awarded the appellant \$125,000 inclusive of Contract Disputes Act interest, with no further interest payable.

QUESTIONS PRESENTED

- Whether the Board should enter judgment pursuant to the parties’ stipulation and agreement.
- What monetary relief should be awarded to the appellant under the consent judgment.

HOLDINGS

- 1. The Board sustained the appeal and entered a consent judgment in favor of the appellant pursuant to the parties’ stipulation and agreement.
- 2. The appellant was awarded \$125,000 as a monetary award under the consent judgment; the amount included Contract Disputes Act interest, and no further interest would be paid.

KEY QUOTATIONS

“In the nature of a consent judgment, the Board makes a monetary award to appellant in the amount of \$125,000. This amount is inclusive of Contract Disputes Act interest. No further interest shall be paid.”

FACTUAL BACKGROUND

The parties disputed matters arising under Contract No. FA5685-15-D-0002. They resolved the dispute and stipulated to a monetary award in favor of the appellant. The stipulated award was \$125,000, inclusive of Contract Disputes Act interest, with no further interest to be paid.

PROCEDURAL HISTORY

The appeal arose under Contract No. FA5685-15-D-0002. After resolving the dispute, the parties submitted a stipulation and agreement requesting a consent judgment, which the Board entered.
