Jerartis Icon v. State of Florida

No. No. 3D25-0772, Third District Court of Appeal of Florida (October 22, 2025)

SUMMARY

The Third District Court of Appeal of Florida affirmed an order striking Jerartis Icon’s motion to clarify concurrent sentences and jail with prison credits as successive. The court held that Florida Rule of Criminal Procedure 3.801(d) prohibits consideration of a successive motion for jail credit, and that the attached prior motion and denial established the motion’s successive nature.

QUESTIONS PRESENTED

1. Whether the trial court erred by striking Icon's April 2, 2024 Rule 3.801 motion as successive.

HOLDINGS

1. Because Rule 3.801(d) expressly prohibits a trial court from considering a successive motion for jail credit, the trial court did not err by striking Icon's successive motion.

KEY QUOTATIONS

“Because rule 3.801(d) expressly prohibits a trial court from considering a successive motion for jail credit, the trial court did not err by entering the challenged Order striking the Motion.” (2)

FACTUAL BACKGROUND

Icon sought clarification of concurrent sentences and jail and prison credits through a Florida Rule of Criminal Procedure 3.801 motion. The record showed that he had previously filed a Rule 3.801 motion addressing jail credit, and that the trial court had denied it. His later motion was therefore successive.

PROCEDURAL HISTORY

Icon filed an initial Florida Rule of Criminal Procedure 3.801 motion concerning jail credit on November 27, 2023. The circuit court denied that motion on December 15, 2023. Icon then filed a second motion on April 2, 2024, which the circuit court struck as successive in a March 31, 2025 order. The Third District Court of Appeal affirmed.

DISPOSITION

affirmed
