Yujing Shentu v. Director, ICE Honolulu Field Office

SUMMARY

The United States District Court for the District of Hawaii dismissed Yujing Shentu’s petition under 28 U.S.C. § 2241 for lack of jurisdiction because she was not in custody when the petition was filed. The court concluded that GPS monitoring and the threat of future detention did not satisfy the habeas statute’s custody requirement and denied the remaining requests for relief as moot.

PRACTICE AREAS

QUESTIONS PRESENTED

1. Whether the Court had jurisdiction under 28 U.S.C. § 2241 when Shentu was not in physical custody and was not subject to a final order of removal.
2. Whether GPS monitoring and the threat of future detention satisfied the in-custody requirement for federal habeas jurisdiction.
3. Whether Shentu's remaining requests for relief should be denied as moot after dismissal of the petition.

HOLDINGS

1. A petitioner who is not in custody when a § 2241 petition is filed does not satisfy the statute's in-custody requirement, and the district court therefore lacks jurisdiction over the petition.
2. Electronic monitoring and the threat of future confinement, without more, do not satisfy the in-custody requirement for a § 2241 petition.

KEY QUOTATIONS

“In short, nothing in Shentu’s memorandum undermines the Court’s conclusion that it lacks jurisdiction to consider the petition because Shentu is not “in custody” under 28 U.S.C. § 2241.”

“The Petition, ECF No. 1, is therefore DISMISSED for lack of jurisdiction, and all other pending requests for relief in this action are DENIED as moot.”

FACTUAL BACKGROUND

Shentu was not in physical custody and was not subject to a final order of removal when she filed her § 2241 petition. She argued that GPS monitoring and the threat of future detention satisfied the statute's in-custody requirement. The Court rejected those arguments, concluding that neither electronic monitoring nor a threat of confinement established custody for purposes of § 2241.

PROCEDURAL HISTORY

Shentu filed a § 2241 habeas petition challenging matters related to her immigration detention and submitted several additional requests for relief. Respondent opposed the filings and argued that the Court lacked jurisdiction because Shentu was not in custody. After an April 8, 2026 hearing, the Court held its jurisdictional ruling in abeyance to allow Shentu to respond; after considering her April 15 memorandum, the Court dismissed the petition and denied the remaining requests as moot.
