Hem v. Toyota Motor Corp.

8 N.M. Ct. App. 245 (2015) · No. No. 33,775 · Decided June 25, 2015

SUMMARY

The New Mexico Supreme Court answers two certified questions concerning Article IV, Section 32 of the New Mexico Constitution and a state hospital's compromise of a patient's hospital lien. The Court holds that the provision's first clause limits only the Legislature and that a state hospital may compromise an undisputed patient debt when the compromise is approved through payment into the treasury or a proper court proceeding. The Court partially overrules *Gutierrez v. Gutierrez* to the extent it required a good-faith dispute over liability or amount owed.

QUESTIONS PRESENTED

1. Whether the first clause of Article IV, Section 32 of the New Mexico Constitution limits only the Legislature or applies to the State generally.
2. Whether Article IV, Section 32 prohibits a state hospital from compromising an undisputed debt owed by a patient when the patient's ability to pay is doubtful and the compromise is supported by consideration.
3. Whether the federal interpleader proceeding could constitute a proper court proceeding under Article IV, Section 32 for approval and enforcement of the hospital's compromise agreement.

HOLDINGS

1. The first clause of Article IV, Section 32 is strictly a limitation on the Legislature and does not apply to nonlegislative state actors such as a state hospital.
2. Article IV, Section 32 does not prohibit a state hospital from compromising an undisputed obligation owed by a patient-debtor, even when there is no dispute about the amount or liability.
3. The pending federal interpleader proceeding constitutes a proper proceeding in court through which the hospital compromise may be approved, the lien reduced, and the patient's debt extinguished.

KEY QUOTATIONS

“Our answer to the second certified question is that Article IV, Section 32 of the New Mexico Constitution does not prohibit UNMH from agreeing to compromise the amount owed by a patient-debtor.” (¶ 3)

“We overrule Gutierrez and hold that under Article IV, Section 32 a state hospital is permitted to compromise on a debt owed to it where there is payment into the treasury or a proper court proceeding.” (¶ 27)

FACTUAL BACKGROUND

Hem was injured when his Toyota truck separated from the U-Haul trailer it was towing, causing the truck to roll over. The University of New Mexico Hospital treated Hem and recorded a hospital lien for his medical bills, but later agreed to accept a reduced amount in exchange for Hem's initial attorney relinquishing statutory priority to settlement funds. After Hem's federal action resulted in a settlement and a dispute arose over whether the settlement proceeds should go first to the hospital or Hem's attorneys, Toyota deposited the disputed funds into the federal court's registry.

PROCEDURAL HISTORY

Dara Hem's federal tort action arose from a truck-and-trailer accident and was ultimately transferred from Texas to the United States District Court for the District of New Mexico. After a settlement and a dispute between Hem's attorneys and the University of New Mexico Hospital over priority to settlement proceeds and a reduced hospital lien, Toyota deposited the disputed funds into the federal court's registry through an interpleader proceeding. The federal district court certified two questions concerning Article IV, Section 32 of the New Mexico Constitution to the New Mexico Supreme Court.

operation, University of New Mexico Hospital 1 OPINION 2 VIGIL, Chief Justice.

3 {1} In this case we determine whether an agreement by a state hospital to reduce 4 the amount
of a lien for medical services rendered violates Article IV, Section 32 of 5 the New Mexico
Constitution. This matter comes before the Court by way of 6 certification from the United States

District Court for the District of New Mexico 7 pursuant to NMSA 1978, Section 39-7-4 (1997) and Rule 12-607 NMRA (2007).

The 8 questions certified to this Court arose out of an interpleader proceeding in the federal 9 district court between Turner & Associates (Turner), attorneys for the plaintiff Dara 10 Hem (Hem), and the University of New Mexico Hospital (UNMH), which treated 11 Hem for injuries. UNMH argues it has priority over settlement funds pursuant to an 12 agreement between itself and Hem's initial attorney, Clay Miller (Miller), in which 13 Miller agreed to subrogate his statutory priority to settlement funds to UNMH.

In 14 exchange, UNMH agreed to reduce the amount of the lien imposed for Hem's 15 outstanding medical bills. Turner argues that this agreement is unconstitutional. 16 Therefore, Turner argues that it has a priority right to collect fees and costs out of the 17 interpleaded settlement funds prior to the satisfaction of the hospital lien, pursuant 18 to the Hospital Lien Act, NMSA 1978, Section 48-8-1 to -7 (1961, as amended 19 through 1995).

1 {2} In order to resolve the matter, the federal district court certified two questions 2 to this Court concerning the application of Article IV, Section 32 of the New Mexico 3 Constitution. The first question is whether the first clause of Section 32 is a limitation 4 applicable only to acts of the Legislature, as this Court held in *State v. State 5 Investment Company*, 1925-NMSC-017, ¶ 13, 30 N.M.

491, 239 P. 741, or if it 6 applies to the State in general, as indicated in *Gutierrez v. Gutierrez*, 1983-NMSC- 7 016, ¶ 8, 99 N.M. 333, 657 P.2d 1182. The second certified question is whether 8 Section 32 prohibits a state hospital from compromising a debt owed by a patient- 9 debtor, where the amount of the debt owed is not disputed, but the patient-debtor's 10 ability to pay is doubtful and the compromise agreement is supported by 11 consideration.

12 {3} In response to the first certified question, we hold that the first clause of 13 Section 32 was correctly interpreted in *State Investment* and is strictly a limitation on 14 the Legislature. Our answer to the second certified question is that Article IV, Section 15 32 of the New Mexico Constitution does not prohibit UNMH from agreeing to 16 compromise the amount owed by a patient-debtor.

17 {4} In so deciding, we revisit this Court's interpretation of Article IV, Section 32 18 in *Gutierrez*. Because we find nothing in the Constitution to support *Gutierrez's* 2 1 holding that a state hospital cannot compromise on a debt owed to it unless there is 2 a good faith dispute as to the amount or liability for that debt, we conclude that 3 *Gutierrez* must be overruled to the extent that it so holds.

We hold that Article IV, 4 Section 32 of the New Mexico Constitution simply requires that in order to extinguish 5 debts or liabilities owed to the State, there must either be payment into the treasury

6 or a proper court proceeding. 7 I. BACKGROUND 8 {5} In March 2007, Hem brought suit in a Texas federal court after he was 9 seriously injured in an accident.

Hem was traveling through northern New Mexico 10 when his Toyota truck separated from the U-Haul trailer it was towing, causing the 11 truck to roll over several times. After treating Hem for his injuries, UNMH recorded 12 a hospital lien for Hem's outstanding medical bills.

The lien would attach to any 13 future judgment or settlement he might procure from a lawsuit, pursuant to the 14 Hospital Lien Act. See § 48-8-1(A) ("Every hospital located within the state that 15 furnishes emergency, medical or other service to any patient injured by reason of an 16 accident... is entitled to assert a lien upon that part of the judgment, settlement or 17 compromise going, or belonging to such patient, less the amount paid for attorneys' 18 fees, court costs and other expenses necessary thereto in obtaining the judgment, 3 1 settlement or compromise....").

Although Hem did not dispute the amount owed, 2 UNMH agreed to compromise on the lien amount and accept a lesser amount as 3 payment in full. In exchange, one of Hem's attorneys, Miller, agreed to give up his 4 statutory priority over settlement funds already obtained from U-Haul and some 5 anticipated settlement funds from Toyota, so UNMH would be paid first.

See id. 6 (providing that a hospital lien attaches to the amount of a patient's recovery 7 remaining after the payment of attorneys' fees). This compromise was confirmed in 8 a letter written by Miller to UNMH (the UNMH Agreement).

After sending the letter, 9 Miller paid the U-Haul settlement funds he had already received to UNMH, per the 10 UNMH Agreement. 11 {6} In September 2009, the Texas court transferred Hem's case against Toyota to 12 New Mexico.

The case went to trial in January 2011, and while the jury deliberated, 13 the parties reached a "Contingent Confidential Settlement Agreement" (Toyota 14 Agreement), under which Hem would recover whether or not the jury found in his 15 favor, but the amount of recovery was dependent on the jury's verdict.

The jury 16 ultimately returned a verdict in Toyota's favor, and in February 2011, the federal 17 district court entered a final judgment dismissing the action. In June 2011, Hem filed 18 a motion to enforce the Toyota Agreement.

Because there was a dispute over whether 4 1 the settlement funds should be paid to UNMH or to Turner, Toyota filed a motion in 2 interpleader to allow the federal district court to determine who was entitled to the 3 funds.

The federal district court entered an order permitting Toyota to pay the amount 4 remaining on the UNMH lien into the court registry and discharged Toyota from the 5 lawsuit. At this time, the remaining dispute in the interpleader proceeding is between 6 Turner and UNMH; Hem claims no

interest in the settlement funds. 7 {7} UNMH argues that it is entitled to be paid out of the Toyota Settlement funds 8 before Turner because of the terms of the UNMH Agreement.

Turner argues that the 9 UNMH Agreement is unenforceable in light of Article IV, Section 32 of the New 10 Mexico Constitution, thereby entitling Hem's attorneys to the money pursuant to the 11 Hospital Lien Act. See § 48-8-1(A) (providing that attorneys fees are taken out of 12 settlement proceeds before such proceeds are used to pay a hospital lien).

The 13 disagreement over what Section 32 requires engendered the certified questions. We 14 accepted certification. 15 II. DISCUSSION 16 {8} The certified questions require us to interpret Article IV, Section 32 of the New 17 Mexico Constitution. "We review issues of statutory and constitutional interpretation 18 de novo." State v. Ordunez, 2012-NMSC-024, ¶ 6, 283 P.3d 282 (internal quotation 5 1 marks and citation omitted).

2 {9} The provision at issue, Article IV, Section 32 of the New Mexico Constitution, 3 reads, in pertinent part: 4 No obligation or liability of any person, association or corporation 5 held or owned by or owing to the state, or any municipal corporation 6 therein, shall ever be exchanged, transferred, remitted, released, 7 postponed or in any way diminished by the legislature, nor shall any 8 such obligation or liability be extinguished except by the payment 9 thereof into the proper treasury, or by proper proceeding in court.

10 A. The First Clause of Article IV, Section 32 Is Strictly A Limitation on the 11 Legislature and Is Therefore Not Relevant to These Proceedings 12 {10} When construing constitutional provisions, we keep in mind that "the rules of 13 statutory construction apply equally to constitutional construction." State v. Boyse, 14 2013-NMSC-024, ¶ 8, 303 P.3d 830 (internal quotation marks and citation omitted).

15 Just as if we were interpreting a statute, to determine the meaning of a constitutional 16 provision, we begin with the language used in the provision and "the plain meaning 17 of that language." State v. Maestas, 2007-NMSC-001, ¶ 9, 140 N.M. 836, 149 P.3d 18 933. Where the meaning of that language is "clear and unambiguous, we must give 19 effect to that language and refrain from further... interpretation." Sims v. Sims, 20 1996-NMSC-078, ¶ 17, 122 N.M.

618, 930 P.2d 153 (internal quotation marks and 21 citation omitted). 6 1 {11} The plain language of the first clause of Section 32—"No obligation or liability 2 of any person, association or corporation held or owned by or owing to the state, or 3 any municipal corporation therein, shall ever be exchanged, transferred, remitted, 4 released, postponed or in any way diminished by the legislature"—unambiguously 5 applies solely to the Legislature.

N.M. Const. art. IV, § 32. Although it mentions the 6 state generally in the context of debts "owned by or owing to the state," the only 7 potential actor referenced in this provision is the Legislature. Id (emphasis added). 8 Accordingly, in State Investment, this Court held that the first

clause of Section 32 9 restricts only the Legislature from diminishing obligations owed to the State, and 10 therefore the Attorney General and district attorneys were permitted to compromise 11 on the defendant's tax liability.

See 1925-NMSC-017, ¶ 13. We agree with State 12 Investment that the first clause of Section 32 is appropriately characterized as 13 applying only to the Legislature. 14 {12} Although the meaning of the plain language is unambiguous, the first certified 15 question arises from an apparent inconsistency between two New Mexico Supreme 16 Court cases—State Investment and Gutierrez—that interpreted Section 32.

In Gutierrez, 17 the Court determined that Section 32 prohibits the State in general from 18 compromising on “the amount owed to it unless a good faith dispute exists as to the 7 1 amount of indebtedness or liability.” 1983-NMSC-016, ¶ 8.

However, the Gutierrez 2 opinion did not include a holding specific to the first clause of Section 32. See 3 generally Gutierrez, 1983-NMSC-016. Because the first clause clearly applies only 4 to the Legislature, we conclude that Gutierrez was interpreting the second clause of 5 Section 32 requiring a proper court proceeding, not the first clause regarding the 6 Legislature's attempts to compromise debt.

Therefore, the conflict between State 7 Investment and Gutierrez is limited to the interpretation of the second clause of 8 Section 32, which applies to the State in general, and has no bearing on our 9 interpretation of the first clause. Further, as we discuss below, the remaining conflict 10 between the two cases is hereby eliminated because we partially overrule Gutierrez.

11 {13} In answering the first certified question, we conclude that the first clause of 12 Section 32 limits only the Legislature. Thus, it is irrelevant to the present case as no 13 act by the Legislature is implicated here. Instead, in order to address the second 14 question concerning whether the UNMH Agreement violates Section 32, we must 15 consider it under the second clause of Section 32, as that clause is a limit on the State 16 generally.

17 B. The UNMH Agreement Does Not Violate Article IV, Section 32 of the New 18 Mexico Constitution 19 {14} The second clause of Section 32 provides, “nor shall any such obligation or 8 1 liability be extinguished except by the payment thereof into the proper treasury, or by 2 proper proceeding in court.” N.M. Const. art. IV, § 32.

The phrase “any such 3 obligation” refers to the language of the first clause describing an “obligation or 4 liability of any person, association or corporation held or owned by or owing to the 5 state, or any municipal corporation therein.” *Id.* Unlike the first clause, which 6 provides specifically that these obligations owed to the State cannot be “in any way 7 diminished by the legislature,” nothing in the second clause limits its application to 8 any specific State entity.

Id. (emphasis added). Instead, it applies to all obligations 9 owed to the State and provides that such obligations can only be extinguished either 10 by a full payment to the State treasury or by a proper proceeding in court. 11 {15} Turner relies on this Court’s previous interpretation of Section 32 in Gutierrez 12 to argue that, because there is no dispute as to the amount owed, the UNMH 13 Agreement is unconstitutional, regardless of whether or not a proper court proceeding 14 occurs.

UNMH argues that the proper court proceeding requirement will be satisfied 15 when the federal district court issues its order approving the UNMH Agreement. 16 1. Gutierrez Incorrectly Held that Article IV, Section 32 Requires a Good 17 Faith Dispute as to the Amount Owed or Liability 18 {16} The question in Gutierrez was whether a court could reduce a hospital lien at 19 the patient-debtor’s request, when the hospital was unwilling to compromise.

1983- 9 1 NMSC-016, ¶¶ 1-2, 4. In Gutierrez, the plaintiffs were injured in a car accident, and 2 the hospital filed liens for debt incurred as a result of the plaintiffs’ treatment. Id. ¶¶ 3 1, 3. When the hospital declined to compromise the lien amounts, the plaintiffs filed 4 complaints asking the district court for an order voiding the hospital liens. Id. ¶ 4.

The 5 district court denied the motion, determining that it “lack[ed] equitable or 6 discretionary power to void or reduce the amount of... the hospital liens.” Id. ¶ 6. 7 This Court affirmed, holding that the district court could not order the hospital to 8 reduce its lien where there was no dispute as to the validity of the lien amount. Id. ¶ 9 8. 10 {17} The holdings announced in Gutierrez exceeded the scope of the dispute before 11 the Court.

The Gutierrez Court determined that “the New Mexico Constitution 12 prohibits UNM Hospital from accepting a payment of less than the full amount of an 13 undisputed legal obligation as a satisfaction,” Gutierrez, 1983-NMSC-016, ¶ 8.

The 14 Court added, “The State cannot compromise the amount owed to it unless a good faith 15 dispute exists as to the amount of indebtedness or liability.” Id. Thus, although 16 Gutierrez dealt with a situation in which the hospital did not agree to reduce the 17 amount owed to it, the Gutierrez Court’s holding would apply even where a state 18 hospital did agree to compromise with patient-debtors on its own behalf.

See id. 10 1 {18} The Gutierrez Court also held that in order for a state hospital to reduce a debt, 2 there must be a good faith dispute as to the amount owed. Id. The Court apparently 3 read this “good faith dispute” requirement into the definition of a proper court 4 proceeding. See N.M. Const. art IV, § 32 (providing that no debts owed to the state 5 shall “be extinguished except by the payment thereof into the proper treasury, or by 6 proper proceeding in court”).

However, Section 32 makes no reference to a good faith 7 dispute. What Section 32 does require is either payment into the treasury or a proper 8 proceeding in court. 9 {19} In support of this

interpretation, the Gutierrez Court cited two cases from other 10 jurisdictions—Wade v. Clemmons, 377 N.Y.S.2d 415 (Sup. Ct. 1975) and Dade 11 County v. Bodie, 237 So.2d 553 (Fla.

Dist. Ct. App. 1970). Both Wade and Bodie are 12 out-of-state cases interpreting the hospital lien acts of their respective states, not the 13 New Mexico Constitution. Further, neither case holds that a state hospital cannot 14 agree to reduce a debt owed to it without a good faith dispute as to liability.

In Bodie, 15 the hospital did not enter into an agreement to reduce the lien, and the court held that 16 Florida's hospital lien act gave no discretionary power to courts to reduce a hospital's 17 lien amount. 237 So.2d at 554.

The court remanded the case for a determination of 18 the validity and appropriate amount of the lien. Id at 555. Under Bodie, a court cannot 11 1 reduce a hospital lien in the absence of an agreement unless the validity or amount 2 of the lien is in dispute. This proposition has no application when, as here, the 3 hospital has in fact agreed to compromise the debt owed to it.

4 {20} On the other hand, in Wade, although there was no dispute concerning the 5 amount owed by the plaintiff to the hospital, the hospital agreed to reduce the 6 plaintiff's lien by \$1,500. 377 N.Y.S.2d at 418. The plaintiff's attorney argued for a 7 greater reduction, in the amount of \$2,433.23, to which the hospital did not agree. Id. 8 Although the Wade court held that it "d[id] not have discretionary power to impose 9 a reduction of the hospital lien" to the full extent requested by the plaintiff's attorney, 10 it ultimately entered an order reducing the lien "in accordance with [the hospital's] 11 consent." Id. at 418, 420.

Wade, therefore, supports the Gutierrez holding that a court 12 cannot force the hospital to reduce the lien where the amount is not in dispute. 13 However, it does not support the determination that a hospital cannot agree to 14 compromise an amount owed to it because the Wade court ultimately approved the 15 reduction of the amount to the extent that the hospital agreed to compromise.

16 {21} Thus, Bodie is factually distinguishable from the case at hand because there the 17 hospital did not agree to compromise the amount owed, and the conclusion in Wade 18 is actually contrary to the proposition for which it was cited in Gutierrez.

The 12 1 Gutierrez holding that "the New Mexico Constitution prohibits UNM Hospital from 2 accepting payment of less than the full amount of an undisputed legal obligation as 3 a satisfaction," 1983-NMSC-016, ¶ 8, which relies upon these two cases, is therefore 4 unsupported by precedent.

The Gutierrez holding that a court lacks the equitable or 5 discretionary power to void or reduce public hospital liens without the hospital's 6 agreement and absent a good faith dispute is still good law. However, a public 7 hospital does have the authority to compromise on its own accord.

We hereby 8 overrule *Gutierrez* to the extent that it holds that the State cannot compromise on 9 debts owed to it unless there is a good faith dispute as to the amount owed or liability. 10 {22} UNMH, as a state hospital, may compromise undisputed obligations with sick 11 or indigent patient-debtors because it is constitutionally permitted to do so. 12 Additional authority for such action can be found in Article IX, Section 14 of the 13 New Mexico Constitution, which provides that, although the state is generally 14 prohibited from “mak[ing] any donation to or in aid of any person,... [n]othing in 15 this section prohibits the state or any county or municipality from making provision 16 for the care and maintenance of sick and indigent persons.” 17 {23} “[C]onstitutional provisions should be read together and harmonized in their 18 application if possible.” *Denish v. Johnson*, 1996-NMSC-005, ¶ 32, 121 N.M.

280, 13 1 910 P.2d 914 (internal quotation marks and citation omitted). As discussed, Article 2 IV, Section 32 allows for the extinguishment of debt owed to the State where there 3 is a proper court proceeding. Article IX, Section 14 specially allows for the provision 4 of aid for the care and maintenance of sick and indigent persons. When read together, 5 Article IX, Section 14 and Article IV, Section 32 permit state government to 6 compromise undisputed obligations with sick or indigent patient-debtors, so long as 7 there is a proper court proceeding.

8 {24} Accordingly, we hold that state hospitals may compromise with patient-debtors 9 even when no dispute as to liability or amount owed is present, in accordance with 10 state policies allowing aid to the sick or indigent.

To prohibit state hospitals from 11 compromising undisputed patient debts would serve only to require indigent patients 12 seeking settlement to sue for relief rather than allowing them to negotiate with the 13 hospital. This would result in unnecessary litigation and is contrary to state policy, 14 as supported by Article IX, Section 14, and other state laws.

See, e.g., Indigent 15 Hospital and County Health Care Act, NMSA 1978, §§ 27-5-1 to -18 (1965, as 16 amended through 2014). 17 2. The Requirement of a Proper Proceeding in Court Can Be Satisfied in 18 This Case 19 {25} Article IV, Section 32 requires all obligations to the state to be satisfied by 14 1 payment into the treasury or proper proceeding in court.

Article IV, Section 32 “is 2 undoubtedly intended to prevent public officials from releasing debts justly owed to 3 the state and to discourage collusion between public officials and private citizens.” 4 N.M. Att’y Gen. Op. 69-69 (1969). Absent allegations of fraud, misrepresentation, 5 or mistake, it is to be presumed that these settlements are entered into based upon 6 sufficient and proper facts and in the utmost good faith by counsel for the state.

State 7 Investment, 1925-NMSC-017, ¶ 16. 8 {26} A proper court proceeding is satisfied where a court reviews the agreement for 9 issues of corruption, nepotism, etc., and issues an order approving a settlement 10 agreement between a hospital and patient.

Here, the federal district court has also reviewed the agreement for the presence of consideration in satisfaction of the pre-existing duty rule. The federal district court notes, and we agree, that it retains jurisdiction over the matter: the parties to the UNMH Agreement are before the federal district court, the federal district court has subject matter jurisdiction over the underlying dispute between Hem and the Toyota Defendants, and the disputed portion of the proceeds of the Toyota Agreement have been deposited into the registry of the federal district court.

In the event that the federal district court determines that the UNMH Agreement is enforceable against the proceeds of the Toyota Agreement, the federal district court has the power to issue the judgment contemplated by the “proper proceeding in court” language of Article IV, Section 32.

The fact that no court has as yet entered an order approving and enforcing the UNMH Agreement is immaterial. We therefore agree with the federal district court that the present interpleader proceeding is a proper proceeding in court by which the UNMH Agreement may be approved, UNMH’s lien reduced, and Hem’s debt to UNMH extinguished. III. CONCLUSION {27} We conclude that the UNMH agreement is not prohibited by Article IV, Section 32 of the New Mexico Constitution.

We answer the questions certified to this Court as follows: (1) the first clause of Article IV, Section 32 is solely a limitation on the Legislature; and (2) the UNMH Agreement does not violate Article IV, Section 32 of the New Mexico Constitution.

We overrule Gutierrez and hold that under Article IV, Section 32 a state hospital is permitted to compromise on a debt owed to it where there is payment into the treasury or a proper court proceeding. {28} IT IS SO ORDERED.
