SUMMARY

The United States District Court for the Northern District of Alabama adopts a magistrate judge’s Report and Recommendation recommending dismissal of the action for failure to prosecute. Because no party objected, the court reviewed the recommendation for clear error, dismissed the case without prejudice, and directed the Clerk to close the case.

QUESTIONS PRESENTED

1. Whether the district court should adopt the magistrate judge's Report and Recommendation when no party objected to it.
2. Whether the action should be dismissed without prejudice for failure to prosecute.

HOLDINGS

1. When no party objects to a magistrate judge's report, the district court reviews the unchallenged portions for clear error and may accept, reject, or modify the report in whole or in part.
2. The action should be dismissed without prejudice for failure to prosecute.

KEY QUOTATIONS

“Having reviewed the proposed findings and recommendations for clear error, the Court concludes that the Magistrate Judge’s Report and Recommendation (Doc. 33) should be ACCEPTED and hereby ADOPTS it as the findings of the Court.”

“The case is therefore DISMISSED WITHOUT PREJUDICE.”

FACTUAL BACKGROUND

The plaintiff's action was subject to a Report and Recommendation recommending dismissal for failure to prosecute. No party filed objections to the recommendation. Upon review, the district court found no clear error and adopted the recommendation.

PROCEDURAL HISTORY

U.S. Magistrate Judge John H. England, III, issued a Report and Recommendation on October 22, 2025, recommending dismissal without prejudice for failure to prosecute. No party objected. The district court reviewed the recommendation for clear error, adopted it as the findings of the court, dismissed the action without prejudice, and directed the clerk to close the case.
