The witness will testify on direct examination as a key prosecution witness and his testimony
seeks to implicate inculcate Defendant as having engaged in the criminal conduct alleged herein.
II. If the prosecution has made either promises or implied that it will make concessions to the
witness in. order to induce his testimony, the defense has a right to know the nature of the
concession made, promised or implied to the witness or his representatives in order to prove that
the witness' testimony was biased by such decisions.

Without such disclosure, defense counsel can only speculate that the concessions probably involve
doubtful proof on the issue of credibility. To deny disclosure of information which could influence
the witness testimony violates Defendant's rightto due process oflaw. WHEREFORE, PREMISES
