Dolorfino v. University Medical Center of Southern Nevada

SUMMARY

This Nevada Supreme Court case concerns an appeal involving Susan Dolorfino, Robert Harper Odell, Jr., and the University Medical Center of Southern Nevada. The court initially issued an authored opinion on October 4, 2018, reversing and remanding the district court judgment. After granting en banc reconsideration, the court issued an order on October 21, 2019, affirming in part, reversing in part, and remanding the matter.

PROCEDURAL HISTORY

Susan Dolorfino appealed a district court judgment to the Supreme Court of Nevada. After oral argument, the court issued an authored opinion reversing and remanding the matter. Respondent Robert Harper Odell, Jr.

sought rehearing, which was denied; he then sought en banc reconsideration, which was granted in 2019. The en banc court subsequently affirmed in part, reversed in part, and remanded.
