Frederick Banks v. Jordan Cisco, et al.

SUMMARY

The United States District Court for the District of New Jersey denied Frederick Banks’s motion for reconsideration of the denial of his application to proceed in forma pauperis. The court held that Banks was subject to the Prison Litigation Reform Act’s three-strikes provision because he was incarcerated when he filed the complaint and had at least three qualifying prior dismissals. The court concluded that Banks’s arguments concerning his incarceration history, American Indian status, and the prior dismissals did not warrant reconsideration.

STANDARD OF REVIEW	A motion for reconsideration under Local Civil Rule 7.1(i) is granted only in extraordinary circumstances upon an intervening change in controlling law, newly available evidence, or the need to correct a clear error of law or fact or prevent manifest injustice; the prior decision must have overlooked a factual or legal issue that may alter the disposition.

PRACTICE AREAS

QUESTIONS PRESENTED

1. Whether plaintiff established grounds for reconsideration under Local Civil Rule 7.1(i).
2. Whether the PLRA applies to plaintiff despite his assertion that he is an American Indian and has not been continuously incarcerated.
3. Whether plaintiff had at least three qualifying dismissals for purposes of the PLRA three-strikes provision.

HOLDINGS

1. Reconsideration was not warranted because plaintiff did not identify an intervening change in controlling law, newly available evidence, a clear error of law or fact, manifest injustice, or an overlooked issue that could alter the disposition.
2. The PLRA applies to plaintiff because he was incarcerated in federal prison and serving a sentence when he filed his complaint and in forma pauperis application; continuous incarceration and plaintiff's asserted American Indian status do not alter that result.
3. Plaintiff had at least three qualifying dismissals and therefore was subject to the PLRA's three-strikes provision.

KEY QUOTATIONS

“Relief under Local Civil Rule 7.1(i) ‘is an extraordinary remedy that is granted ‘very sparingly.’” (at 272)

“To prevail, the movant must present ‘(1) an intervening change in the controlling law; (2) the availability of new evidence that was not available when the court [made its initial decision]; or (3) the need to correct a clear error of law or fact or to prevent manifest injustice.’” (at 677)

“The ‘three strikes’ provision was ‘designed to filter out the bad claims and facilitate consideration of the good.’” (at 539)

FACTUAL BACKGROUND

Frederick Banks, a prisoner serving a sentence at FCI Fort Dix, submitted a Bivens complaint and sought to proceed in forma pauperis. He was incarcerated when he filed the complaint and application. The court identified at least three prior qualifying dismissals, including dismissals of appeals as frivolous and a complaint for failure to state a claim.

PROCEDURAL HISTORY

Plaintiff filed a Bivens complaint and an application to proceed in forma pauperis. The court denied the application on December 30, 2025, finding that plaintiff was subject to the PLRA's three-strikes provision. Plaintiff moved for reconsideration, arguing that the PLRA did not apply to him and that he lacked three qualifying dismissals. The court denied the motion.
