FACTUAL BACKGROUND

Donald Adkins, proceeding pro se, submitted a mandamus-related motion to the Twelfth Court of Appeals. After the clerk notified him that the filing had been recorded as a motion asking why the court should not grant mandamus, Adkins asserted that the filing instead asked why the court should grant mandamus and requested correction of the record.

PROCEDURAL HISTORY

Adkins filed a petitioning motion concerning why the court should grant his petition for mandamus. The clerk's notice reportedly described the filing as asking why the court should not grant mandamus, and Adkins requested that the record be corrected by changing "should not" to "should."
