SUMMARY

The Texas First Court of Appeals dismissed an appeal from an order modifying the parent-child relationship after appellant's counsel reported that the parties had entered into an agreed order and that appellant no longer wished to pursue the appeal. The court construed counsel's letter as a motion to dismiss, granted it under Texas Rules of Appellate Procedure 42.1(a) and 43.2(f), and dismissed other pending motions as moot.

Appellant's counsel has filed a letter stating that the parties had entered into an Agreed Order in Suit to Modify the Parent-Child Relationship on March 7, 2024 and that there was no longer a need to pursue the appeal. Appellee has not opposed this letter.

Because counsel asserts that appellant no longer wishes to pursue her appeal, we construe this letter as a motion to dismiss the appeal. Accordingly, we grant the motion and dismiss the appeal. See TEX. R. APP. P. 42.1(a), 43.2(f). Any other pending motions are dismissed as moot. PER CURIAM Panel consists of Chief Justice Adams and Justices Guerra and Guiney.
