In the Matter of the Reinstatement of Colin Richard Barrett to Membership in the Oklahoma Bar Association and to the Roll of Attorneys

2021 OK 65 · No. SCBD-7083 · Decided December 7, 2021

SUMMARY

The Oklahoma Supreme Court granted Colin Richard Barrett's petition for reinstatement to membership in the Oklahoma Bar Association and to the roll of attorneys. The Court found that Barrett satisfied the applicable procedural requirements and established that he had not engaged in unauthorized practice, possessed the required legal competency, and demonstrated good moral character. Reinstatement was conditioned on payment of \$257.20 in proceeding costs and \$1,275.00 in past and current dues within 90 days.

PROCEDURAL POSTURE	Barrett petitioned the Supreme Court of Oklahoma for reinstatement to membership in the Oklahoma Bar Association and the roll of attorneys after having been stricken from the roll. QUESTIONS PRESENTED

1. Whether Barrett satisfied the procedural and substantive requirements for reinstatement under Rule 11 of the Rules Governing Disciplinary Proceedings.
2. Whether reinstatement should be granted subject to payment of costs and past and current bar dues.

HOLDINGS

1. Barrett established by clear and convincing evidence that he satisfied the procedural requirements for reinstatement, had not engaged in the unauthorized practice of law, possessed the competency and learning required for reinstatement, and possessed the requisite good moral character.
2. Reinstatement should be granted, but it is conditioned on payment of \$257.20 in proceeding costs and \$1,275.00 in past and current dues within 90 days of the order.

“The petitioner has established by clear and convincing evidence that he possesses the good moral character which would entitle him to be reinstated to the Oklahoma Bar Association.” (¶ 1)

“Costs and dues shall be paid within 90 days of the date of this order and reinstatement is conditioned upon such payment.” (¶ 3)

FACTUAL BACKGROUND

Colin Richard Barrett was stricken from the Oklahoma roll of attorneys on June 11, 2018. He petitioned for reinstatement on July 8, 2021, and the Professional Responsibility Tribunal conducted a hearing. The Supreme Court found that Barrett satisfied the procedural requirements for reinstatement, had not engaged in the unauthorized practice of law, possessed the required competency and legal learning, and demonstrated good moral character.

PROCEDURAL HISTORY

Barrett was stricken from the roll of attorneys on June 11, 2018. He filed a reinstatement petition on July 8, 2021. After a Professional Responsibility Tribunal hearing on October 5, 2021, the tribunal recommended reinstatement upon payment of outstanding current and past dues. The Supreme Court granted reinstatement subject to payment of specified costs and dues within 90 days.

the Roll of Attorneys. ORDER ¶1 The petitioner, Colin Richard Barrett was stricken from the roll
of attorneys of the Oklahoma Bar Association on June 11, 2018.

On July 8, 2021, Barrett petitioned this Court for reinstatement as a member of the Oklahoma Bar
Association. On October 5, 2021, the Professional Responsibility Tribunal held a hearing and
recommended that the attorney be reinstated upon the payment of outstanding current and past
dues. Upon consideration of the matter, we find: 1) The petitioner has met all the procedural
requirements necessary for reinstatement in the Oklahoma Bar Association as set out in Rule 11,
Rules Governing Disciplinary Proceedings, 5 O.S.

2011, ch.1, app. 1-A. 2) The petitioner has established by clear and convincing evidence that he
has not engaged in the unauthorized practice of law in the State of Oklahoma. 3) The petitioner
has established by clear and convincing evidence that he possesses the competency and learning in
the law required for reinstatement to the Oklahoma Bar Association. 4) The petitioner has
established by clear and convincing evidence that he possesses the good moral character which
would entitle him to be reinstated to the Oklahoma Bar Association. ¶2 IT IS THEREFORE
ORDERED that the petition of Colin Richard Barrett for reinstatement be granted. ¶3 IT IS
FURTHER ORDERED that Reinstatement is conditioned upon: 1) the payment of \$257.20 in
costs associated with these proceedings; and 2) the payment of \$1275.00 in past and current dues.

Costs and dues shall be paid within 90 days of the date of this order and reinstatement is
conditioned upon such payment. ¶4 DONE BY ORDER OF THE SUPREME COURT THE 6th
