David Lindenmann v. Okta, Inc.

Lindenmann v. Okta · No. 25-13848 (SDW) (AME) · Decided February 11, 2026

SUMMARY

The United States District Court for the District of New Jersey granted Okta, Inc.’s motion to compel arbitration and stay the action. The court held that the plaintiff’s claims under the Family and Medical Leave Act and the New Jersey Law Against Discrimination fell within the parties’ broad arbitration agreement and administratively terminated the matter pending arbitration.

PROCEDURAL POSTURE	Defendant moved to compel arbitration and stay the action under the Federal Arbitration Act. The court granted the motion and administratively terminated the matter pending arbitration.

QUESTIONS PRESENTED

1. Whether a valid arbitration agreement covered Plaintiff's employment-related statutory claims.
2. Whether Plaintiff's claims under the Family and Medical Leave Act and the New Jersey Law Against Discrimination fell within the scope of the arbitration agreement.
3. Whether the action should be stayed or administratively terminated pending arbitration.

HOLDINGS

1. The arbitration agreement covered Plaintiff's claims because it expressly applied to all common-law and statutory claims, whether or not arising out of his employment or its termination.
2. The action was to be administratively terminated until the conclusion of arbitration.

KEY QUOTATIONS

“Plaintiff's claims, including his claims under the Family Medical Leave Act and the New Jersey Law Against Discrimination, clearly fall within the scope of claims covered by the Arbitration Agreement and must be arbitrated.”

“Accordingly, Defendant's Motion to Compel Arbitration and Stay the Action is GRANTED and this matter shall be administratively terminated until the conclusion of the arbitration.”

FACTUAL BACKGROUND

As a condition of his employment with Okta, David Lindenmann signed an arbitration agreement on January 12, 2024. The agreement covered all common-law and statutory claims, whether or not arising out of his employment or its termination, under the JAMS Employment Arbitration Rules and Procedures. Lindenmann did not challenge the agreement's validity; he argued that it did not cover workplace-discrimination claims, including claims under the Family and Medical Leave Act and the New Jersey Law Against Discrimination.

PROCEDURAL HISTORY

Plaintiff filed an employment-related action against Okta, Inc. Defendant moved to compel arbitration and stay the action. The district court determined that the parties had a valid arbitration agreement covering Plaintiff's statutory employment claims and granted the motion.
