SUMMARY

The Armed Services Board of Contract Appeals dismissed, without prejudice, two appeals filed by United Capital Investments Group under Contract No. SPE605-24-D-9406. The dismissal followed the appellant's notice of dismissal, to which the government consented.

HOLDINGS

1. The Board dismissed ASBCA Nos. 63990 and 64114 from its docket without prejudice because appellant requested dismissal and the government consented.

FACTUAL BACKGROUND

United Capital Investments Group had two appeals pending before the Armed Services Board of Contract Appeals under Contract No. SPE605-24-D-9406. The appellant submitted a notice requesting dismissal without prejudice, and the government consented. The Board therefore dismissed the appeals without reaching the merits.

PROCEDURAL HISTORY

United Capital Investments Group filed appeals before the Armed Services Board of Contract Appeals under Contract No. SPE605-24-D-9406. By notice dated April 28, 2026, appellant requested dismissal without prejudice; the government consented. The Board dismissed the appeals from its docket without prejudice.
