QUESTIONS PRESENTED

- Whether the court should extend the deadline for the parties to submit their settlement agreement for approval under Cheeks v. Freeport Pancake House, Inc.

HOLDINGS

1. The court granted the requested two-week extension and directed the parties to submit their agreement for approval under *Cheeks v. Freeport Pancake House, Inc.* by December 15, 2025.

FACTUAL BACKGROUND

The court had directed the parties to submit a request for approval of their settlement by December 1, 2025. Plaintiff's counsel reported that a draft settlement agreement had been prepared but that additional time was needed to finalize its details and obtain client signatures. Defense counsel consented to a two-week extension.

PROCEDURAL HISTORY

The court's November 14, 2025 order directed the parties to submit a request for Cheeks approval by December 1, 2025. Plaintiff requested an extension until December 15, 2025 to finalize the settlement agreement and obtain client signatures, and defense counsel consented. The court granted the extension and directed submission of the agreement by December 15, 2025.
