The document provides no substantive facts concerning the estate or the underlying dispute. It states only that Schwager filed a notice of appeal in an incapacitated-estate matter and was instructed regarding preparation and payment for the appellate record.

PROCEDURAL HISTORY

The Harris County Probate Courts Department identified the matter as In the Estate of Ruby S. Peterson, Incapacitated, Cause No. 427208-401. Schwager filed a notice of appeal on February 9, 2015, and the appeal was assigned to the First Court of Appeals. The clerk advised her that the appeal was due March 11, 2015, and requested designation of the documents to be included in the record.
