1. Whether the Seventh Circuit should grant the appellees' motion to amend or correct the January 22, 2026 opinion to correct the appellee's name.

FACTUAL BACKGROUND

The order concerns only a clerical correction to the Seventh Circuit's prior opinion. The prior opinion incorrectly referred to appellee Brad Burkhart as "Brian Burkhart" on pages 2 and 8.

PROCEDURAL HISTORY

Nicholas Zemlick appealed from proceedings in the United States District Court for the Southern District of Indiana, Indianapolis Division, case number 1:22-cv-02319-MPB-MJD. On January 23, 2026, the appellees moved to amend or correct the Seventh Circuit's January 22 opinion, and the court granted the motion to replace the incorrect name "Brian Burkhart" with "Brad Burkhart" on pages 2 and 8.
