In the Matter of the Reinstatement of Jacqueline Forsgren Cronkhite to Membership in the Oklahoma Bar Association and to the Roll of Attorneys

2020 OK 109 · No. SCBD-6905 · Decided December 14, 2020

SUMMARY

The Oklahoma Supreme Court grants Jacqueline Forsgren Cronkhite's petition for reinstatement to membership in the Oklahoma Bar Association and the roll of attorneys. The court finds that she satisfied the applicable procedural, competency, good moral character, and unauthorized-practice requirements, paid current dues and transcript costs, and orders reinstatement effective immediately subject to payment of remaining costs.

QUESTIONS PRESENTED

1. Whether Cronkhite satisfied the procedural requirements for reinstatement under Rule 11 of the Rules Governing Disciplinary Proceedings.
2. Whether Cronkhite established by clear and convincing evidence that she had not engaged in the unauthorized practice of law in Oklahoma.
3. Whether Cronkhite established the competency and legal learning required for reinstatement.
4. Whether Cronkhite established the good moral character required for reinstatement.
5. Whether the petition for reinstatement should be granted subject to payment of the remaining proceeding costs.

HOLDINGS

1. Cronkhite met all procedural requirements necessary for reinstatement in the Oklahoma Bar Association.
2. Cronkhite established by clear and convincing evidence that she had not engaged in the unauthorized practice of law in Oklahoma, possessed the required competency and learning in the law, and possessed the good moral character required for reinstatement.
3. The petition for reinstatement was granted effective immediately, with remaining proceeding costs of \$347.27 due within 90 days.

FACTUAL BACKGROUND

Jacqueline Forsgren Cronkhite was removed from the Oklahoma roll of attorneys for nonpayment of bar dues and failure to comply with mandatory continuing legal education requirements. She resides in Arkansas and is licensed to practice there. After a Professional Responsibility Tribunal hearing and recommendation for reinstatement, she petitioned the Oklahoma Supreme Court, which found that she satisfied the procedural, competency, unauthorized-practice, and moral-character requirements for reinstatement and had paid her outstanding dues and transcript costs.

PROCEDURAL HISTORY

Cronkhite was stricken from the Oklahoma roll of attorneys effective January 1, 2017. A hearing was held before the Trial Panel of the Professional Responsibility Tribunal, which recommended reinstatement. The Oklahoma Supreme Court reviewed the petition and granted reinstatement effective immediately, subject to payment of remaining proceeding costs within 90 days.

and to the Roll of Attorneys. ORDER ¶1 The petitioner, Jacqueline Foresgren Cronkhite
(Cronkhite/attorney) was stricken from the roll of attorneys from the Oklahoma Bar Association
on January 1, 2017, for non payment of dues and non-compliance with mandatory continuing
education.

Petitioner lives in and is licensed to practice law in Arkansas. On March 19, 2020, she petitioned
this Court for reinstatement as a member of the Oklahoma Bar Association. ¶2 On June 11, 2018, a
hearing was held before the Trial Panel of the Professional Responsibility Tribunal and the tribunal
recommended that the attorney be reinstated. Upon consideration of the matter, we find: 1) The
attorney has met all the procedural requirements necessary for reinstatement in the Oklahoma Bar
Association as set out in Rule 11, Rules Governing Disciplinary Proceedings, 5 O.S.

2011, ch.1, app. 1-A. 2) The attorney has established by clear and convincing evidence that she
has not engaged in the unauthorized practice of law in the State of Oklahoma. 3) The attorney has
established by clear and convincing evidence that she possesses the competency and learning in
the law required for reinstatement to the Oklahoma Bar Association. 4) The attorney has
established by clear and convincing evidence that she possesses the good moral character which
would entitle her to be reinstated to the Oklahoma Bar Association.

5) The attorney's bar dues have been paid and brought up to date and she has paid \$1,148.46 for
the costs of the transcripts of the PRT proceeding. ¶3 IT IS THEREFORE ORDERED that the
petition of Jacqueline Forsgren Cronkhite for reinstatement be granted effective immediately.

The remaining costs of \$347.27 for these proceedings shall be paid within 90 days of reinstatement. ¶4 DONE BY ORDER OF THE SUPREME COURT THE 14th DAY OF DECEMBER, 2020. /S/CHIEF JUSTICE ALL JUSTICES CONCUR.
