Genesis Abigail Ochoa Fonseca v. Kristi Noem, et al.

Ochoa Fonseca v. Noem · No. 26-cv-00128-ABA · Decided January 16, 2026

SUMMARY

The United States District Court for the District of Maryland held that Genesis Abigail Ochoa Fonseca’s detention was governed by 8 U.S.C. § 1226(a), rather than the mandatory-detention provisions of § 1225. The court granted habeas relief in part and ordered that she receive a bond hearing before an immigration judge within 10 days, or be released from custody. The court denied her motion for a temporary restraining order.

QUESTIONS PRESENTED

1. Whether Petitioner's detention was governed by 8 U.S.C. § 1225, which provides for mandatory detention in specified circumstances, or 8 U.S.C. § 1226(a), which provides for discretionary detention

during removal proceedings.

2. Whether Petitioner was entitled to a bond hearing under 8 U.S.C. § 1226(a).
3. What remedy was appropriate for Respondents' statutory violation.
4. Whether Petitioner was entitled to a temporary restraining order requiring immediate release.

HOLDINGS

1. Petitioner was detained under 8 U.S.C. § 1226(a), not 8 U.S.C. § 1225.
2. Because Petitioner was detained under § 1226(a), she was entitled to a bond hearing consistent with 8 C.F.R. §§ 236.1(d), 1003.19, and 1236.1(d).
3. The appropriate remedy was an order requiring Respondents to provide Petitioner with a bond hearing within 10 days; if no hearing occurred within that period, Respondents were required to release her from custody.
4. Petitioner's motion for a temporary restraining order was denied.

KEY QUOTATIONS

“For the same reasons stated in Bautista Villanueva, 2026 WL 100595, Petitioner is not subject to mandatory detention under § 1225.”

“If a bond hearing is not held before an Immigration Judge within 10 days of the date of this Order, Respondents shall RELEASE Petitioner from custody;”

FACTUAL BACKGROUND

Petitioner alleged that she is a Honduran citizen apprehended by Border Patrol in 2018, released from custody, and thereafter living in the United States with her spouse and five minor children. She allegedly complied for almost eight years with monthly ICE appointments and removal proceedings, including an asylum merits hearing whose decision was on appeal to the Board of Immigration Appeals. On January 13, 2026, ICE allegedly arrested her without a warrant at a monthly check-in in Baltimore.

PROCEDURAL HISTORY

Petitioner filed the habeas action and temporary-restraining-order motion on January 13, 2026, the same day she was allegedly arrested by ICE without a warrant during a monthly check-in. The parties later submitted a joint notice stating that the factual and legal issues were materially identical to those in *Bautista Villanueva v. Bondi* and *Villanueva Funes v. Noem* and requested incorporation of the filings from those cases. The court granted the habeas petition in part, denied it in part, ordered a bond hearing within 10 days, and denied the motion for a temporary restraining order.

DISPOSITION

REMAND INSTRUCTIONS

Respondents must provide Petitioner with a bond hearing before an Immigration Judge within 10 days. If no hearing is held within that period, Respondents must release Petitioner. The parties must file a joint status report within 14 days. The order does not preclude ICE from imposing reasonable conditions of release.
