SUMMARY

The United States District Court for the District of Maine denied without prejudice Nippon Sanso Matheson, Inc.'s ex parte motion for a temporary restraining order and preliminary injunction. The court held that the plaintiff failed to satisfy Federal Rule of Civil Procedure 65(b)(1) because it did not provide an affidavit or verified complaint showing immediate and irreparable harm or an attorney certification addressing notice. The court ordered the motion and attachments unsealed.

QUESTIONS PRESENTED

1. Whether Matheson satisfied Federal Rule of Civil Procedure 65(b)(1)'s requirements for an ex parte temporary restraining order.
2. Whether the court should issue an emergency temporary restraining order before the defendants received notice and an opportunity to be heard.

HOLDINGS

1. An ex parte temporary restraining order may issue only upon strict compliance with Federal Rule of Civil Procedure 65(b)(1), including specific facts in an affidavit or verified complaint showing immediate and irreparable injury before the adverse party can be heard and a written attorney certification concerning notice.
2. The court would not grant an ex parte temporary restraining order where the plaintiff indicated that it intended to serve the defendants immediately after filing and failed to establish why notice should be dispensed with.

KEY QUOTATIONS

“to serving their underlying purpose of preserving the status quo and preventing irreparable harm just so long as is necessary to hold a hearing, and no longer.” (415 U.S. at 439)

“The Court notes this Order addresses only Plaintiff’s failure to comply with the strict and mandatory provisions of Rule 65(b)(1).” (Order)

FACTUAL BACKGROUND

Matheson alleged that Erik Miskin misappropriated confidential business information. Matheson filed an unverified complaint and, the same day, sought an ex parte temporary restraining order and a preliminary injunction. The motion stated that Mathon intended to serve the complaint and motion on the defendants immediately after filing, but did not include an affidavit showing specific facts establishing imminent irreparable injury or an attorney certification addressing efforts to provide notice and reasons notice should not be required.

PROCEDURAL HISTORY

Matheson filed an unverified complaint alleging federal and state-law violations arising from the alleged misappropriation of confidential business information. It then filed an ex parte motion for a temporary restraining order and a motion for preliminary injunction. The court denied the ex parte request because the filing did not satisfy Rule 65(b)(1), while expressly declining to address the merits of the complaint or preliminary-injunction motion.
