SUMMARY

HOLDINGS

1. The parties' joint stipulation dismissed the action without prejudice and terminated the case under Federal Rule of Civil Procedure 41(a)(1)(A)(ii).

FACTUAL BACKGROUND

The opinion provides no substantive facts concerning the underlying dispute. The material procedural fact is that the appearing parties jointly stipulated on April 23, 2025, to dismissal without prejudice.

PROCEDURAL HISTORY

The action was pending in the United States District Court for the Eastern District of California. On April 23, 2025, the appearing parties filed a joint stipulation dismissing the action without prejudice; the court recognized the termination under Federal Rule of Civil Procedure 41(a)(1)(A)(ii) and ordered the case closed.
