SUMMARY

This document is a stipulation and order in the U.S. District Court for the District of Nevada extending the deadlines for responses and replies concerning several dispositive motions. The court-approved extension changes the response deadline to February 5, 2026, and the reply deadline to March 12, 2026.

13 THE PARTIES, by and through undersigned counsel, stipulate and agree to extend the time 14 for responses and replies regarding Plaintiffs' Motion for Partial Summary Judgment, Defendant 15 Scottsdale Insurance Company's Motion for Summary Judgment, or in the Alternative, Partial 16 Summary Judgment, K&K Insurance Group's Motion for Summary Judgment, or in the Alternative, 17 Partial Summary Judgment, and USA Boxing's Motion for Summary Judgment.

[Respectively ECF 18 Nos. 111, 107, 108, and 109]. 19 The parties previously stipulated, and the Court granted, an extension of this briefing 20 schedule. [See ECF No. 115.] The parties now seek this additional extension. 21 All of the parties agree that an additional extension of the briefing schedule is warranted 22 because this is a complex case and because the pending dispositive motions are lengthy and dense.

23 In addition, a discovery motion [ECF No. 102], is currently pending before the Court and 24 1 motions. Defendants, on the other hand, do not believe that resolution of that pending discovery 2 motion is necessary to complete the briefing for the pending dispositive motions. But Defendants 3 are nonetheless agreeable to an extension of the existing briefing schedule for those dispositive 4 motions as set forth below.

5 In light of the forgoing, the parties seek the following extension of time for response and 6 reply
