ORDER After consideration of the parties’ briefs and the Family Court record—including the transcript of the May 5, 2025 evidentiary hearing—we find it evident that the judgment below should be affirmed on the basis of and for the reasons cited by the Family Court in its May 16, 2025 order granting the appellee’s petition for custody modification.

The Family Court correctly applied the facts to the law applicable to the modification of a prior consent custody order.² To the extent that 1 The Court previously assigned pseudonyms to the parties under Supreme Court Rule 7(d). 2 See 13 Del.
