SUMMARY

This document is a joint stipulation and proposed order in Driscoll’s, Inc. v. California Berry Cultivars, LLC, a federal civil action in the Eastern District of California. The parties requested, and the court ordered, an August 1, 2025 deadline for filing requests to permanently seal confidential materials submitted with their July 25, 2025 opposition filings. The order was entered by Chief United States District Judge Troy L. Nunley on July 23, 2025.

On April 29, 2025, the Court entered an order establishing deadlines for dispositive 6 | motions concerning invalidity counterclaims. (Dkt. 161.) Per that order, the Parties filed summary 7 | judgment motions as to those counterclaims on June 27, 2025. (Dkts. 167, 171.)

The Parties are to 8 | file their opposition briefs by July 25, 2025. 9 2. The Parties anticipate their respective opposition briefs will contain materials 10 | designated confidential under this action’s

stipulated protective order, and that the respective sides 11 | may submit for sealing materials in which the opposite side has a confidentiality interest.

The 12 | Parties anticipate such records will be submitted under seal in the first instance on July 25. 13 3. The Parties acknowledge documents filed with a dispositive motion may be sealed 14 | only upon a showing of “articulate[] compelling reasons supported by specific factual findings.” 15 | *Kamakana v. City & County of Honolulu*, 447 F.3d 1172, 1178 (9th Cir.

2006). The Parties further 16 | acknowledge this Court’s civil standing order provides “The Court will only consider requests to 17 | seal or redact filed by the proponent of sealing or redaction.” 18 4. To allow the Parties the opportunity to review their adversaries’ respective filings 19 | and to timely prepare factual submissions supporting permanent sealing of appropriate confidential 20 | documents contained or referenced with those filings, the Parties request until Friday August 1, 21 | 2025, to file requests (supported by declarations if necessary) to permanently seal records submitted 22 | with the Parties’ July 25, 2025, opposition briefing pursuant to Local Rules 140 and 141.

23 Stipulation. 24 Based on the foregoing and subject to the Court’s approval, the Parties stipulate they shall 25 | have until August 1, 2025, to file requests (including any evidentiary support) to permanently seal 26 | confidential information submitted under seal in the first instance in connection with Parties’ July 27 | 25, 2025, summary judgment opposition filings.

The Parties respectfully request the Court enter 28 | the attached proposed order confirming this schedule.
