FACTUAL BACKGROUND

The appellant's brief was originally due on January 21, 2015. On that date, appellant's attorney moved for a sixty-day extension. Although the clerk could administratively grant a first extension of up to thirty days, the court granted the longer extension and set March 20, 2015, as the filing deadline.

PROCEDURAL HISTORY

The appeal arose from the 437th Judicial District Court of Bexar County, Texas, trial court cause number 2013CR10842W. The appellant's brief was due January 21, 2015. The Fourth Court of Appeals granted the requested extension and ordered that the brief be filed by March 20, 2015, stating that no further extension would be granted.
