SUMMARY

The Texas Court of Appeals, Third District, granted the State's motion to consolidate five related criminal appeals involving Brent William Curry. The court consolidated the appeals under cause number 03-26-00312-CR and dismissed cause numbers 03-26-00308-CR through 03-26-00311-CR.

QUESTIONS PRESENTED

- Whether the State's appeals in five related causes should be consolidated.

2. Whether the four appeals other than cause number 03-26-00312-CR should be dismissed after consolidation.

HOLDINGS

1. The court granted the State's motion to consolidate the five related appeals and ordered that the consolidated appeal proceed under cause number 03-26-00312-CR.
2. Causes 03-26-00308-CR, 03-26-00309-CR, 03-26-00310-CR, and 03-26-00311-CR were dismissed, while cause 03-26-00312-CR remained the operative consolidated appeal.

FACTUAL BACKGROUND

The opinion concerns five related criminal causes involving Brent William Curry. The trial court took judicial notice of documents from Curry's related trial-court causes, and the causes were effectively consolidated for hearing. No substantive facts concerning the underlying criminal allegations were addressed.

PROCEDURAL HISTORY

The trial court effectively consolidated the related causes for hearing by taking judicial notice of documents in Curry's related trial-court causes. The State then moved to consolidate the five appeals. The court granted the motion, consolidated causes 03-26-00308-CR through 03-26-00311-CR into cause 03-26-00312-CR, and dismissed the four former appeals.
