United States v. Paisley Michels

No. 22-1004, United States Court of Appeals for the Eighth Circuit (September 29, 2022)

SUMMARY

The Eighth Circuit affirmed an upward variance from the advisory Guidelines range in revoking supervised release, holding that the district court did not abuse its discretion by imposing an 18-month sentence based on the defendant's repeated violations and contemptuous disregard for supervision conditions. The court also rejected a *Tapia v. United States* challenge, finding no plain error because the district court's reasoning focused on promoting respect for the law and protecting the public, not on enabling rehabilitation or treatment. This case addresses substantive reasonableness review of revocation sentences and the limits of *Tapia* in the supervised release context.

QUESTIONS PRESENTED

1. Whether the district court's upward variance to 18 months' imprisonment upon revocation of supervised release was substantively unreasonable.
2. Whether the district court's sentence violated *Tapia v. United States* by imposing a longer sentence to promote rehabilitation.

HOLDINGS

1. The sentence was not substantively unreasonable; the district court did not commit a clear error of judgment in weighing the § 3553(a) factors.
2. The sentence did not violate *Tapia* because the district court's stated reasons were to promote respect for the law and protect the public, not to enable treatment or promote rehabilitation.

KEY QUOTATIONS

“In this case I have considered all of the factors under 3353(a) and the advisory guidelines and the statutory penalties. This was a very, very serious crime at the time, and I gave the defendant a significant break at the time of her original sentencing. . . . [i]n no small part because she had had a very unstable and violent childhood and I believed that she had the capacity, as a relatively young woman who had been trafficked herself, to make the changes that were necessary to protect herself and society. She has grossly abused the break I gave her. She has grossly abused every break I’ve given her since at supervised release revocation hearings. By my count, and it’s a generous count, she’s violated supervised release at least 24 times that I’m aware of that’s been documented and admitted to over the last 18 months, including three new felony violations[.] . . . I believe that the defendant is absolutely manipulating the situation. I believe that she is dangerous to herself and to others, and I’m done giving her breaks. Clearly the message that I’ve been trying to send has not been received, and clearly we need to reset this situation until the defendant understands how serious her crime was, how serious supervision is, how serious the rules of supervision are, and how seriously I’m going to take further violations.” (at 3-4)

“Tapia held that a sentencing court ‘may not impose or lengthen a prison sentence to enable an offender to complete a treatment program or otherwise to promote rehabilitation.’ 564 U.S. at 335. Here, the district court explained it was varying upward to promote Michels’s respect for the law and to protect the public from further crimes, not to enable treatment or promote rehabilitation.” (at 4)

FACTUAL BACKGROUND

Michels was convicted of violating the Travel Act by facilitating prostitution. After serving a 15-month prison sentence, she began a three-year supervised release term in July 2020. Over the next 18 months, she violated supervised release conditions at least 24 times, including contacting males on social media, sending nude photographs, engaging in prostitution, failing home detention, consuming alcohol, associating with a known felon, unauthorized social media use, failing to communicate truthfully, failing to maintain employment, and failing to register as a sex offender. The district court modified conditions six times, including requiring home detention and placement in a residential reentry center. After release from the reentry center, Michels committed eight violations that led to the revocation proceeding.

PROCEDURAL HISTORY

Michels pleaded guilty to violating the Travel Act by facilitating prostitution, served 15-month prison sentence, began supervised release in July 2020. She violated conditions multiple times, district court modified conditions six times. On December 1, 2021, probation petitioned to revoke supervised release alleging eight violations. Michels stipulated to all eight. District court revoked supervised release and imposed 18-month sentence with 18 months supervised release to follow. Michels appeals.

DISPOSITION

affirmed
