Goodykoontz v. Moore

SUMMARY

The Eighth District Court of Appeals dismissed David Goodykoontz’s procedendo action against Judge Lauren C. Moore as moot. The trial court had ruled on all four underlying motions involving motions for new trial and petitions for postconviction relief.

QUESTIONS PRESENTED

- Whether the procedendo action was moot after the respondent judge entered rulings on all four matters for which the relator sought compelled action.

HOLDINGS

1. A procedendo action seeking to compel rulings is moot when the respondent judge has ruled on all of the matters identified in the action.

“The four journal entries establish that the trial court has proceeded to judgment on the four outstanding matters and that this procedendo action is moot.”

FACTUAL BACKGROUND

Goodykoontz had filed motions for leave to file a late motion for new trial and petitions for postconviction relief in two underlying criminal cases. The trial judge entered journal entries denying two of the matters on November 19, 2025, and denying the remaining two matters on February 5, 2026. Because the trial court had ruled on all four matters, no unresolved duty remained for a procedendo writ to enforce.

PROCEDURAL HISTORY

Goodykoontz filed a procedendo action seeking rulings on four matters pending in two underlying criminal cases. The respondent judge successively filed motions to dismiss based on mootness after entering rulings on the matters. After the final two rulings resolved all four outstanding matters, the Court of Appeals dismissed the procedendo action as moot.
