SUMMARY

This Report and Recommendation addresses pro se pretrial detainee John Oliver Francois’s request for a preliminary and permanent injunction concerning the digital scanning of privileged legal mail. The magistrate judge recommends denying preliminary injunctive relief because the defendants had not been given notice and an opportunity to be heard, and because the request was included in the complaint’s prayer for relief rather than filed as a separate document as required by Local Rule 65.1.

PROCEDURAL POSTURE	A pro se pretrial detainee requested preliminary and permanent injunctive relief in the prayer for relief of his complaint. The magistrate judge issued a report and recommendation that the request for a preliminary injunction be denied.
STANDARD OF REVIEW	A preliminary injunction requires notice to the adverse party and a fair opportunity to present its version of the facts. The report and recommendation was issued under 28 U.S.C. § 636(b)(1)(B) and is subject to district-judge review under § 636(b)(1)(C) and Federal Rule of Civil Procedure 72(b).

QUESTIONS PRESENTED

1. Whether preliminary injunctive relief could issue before the defendants had been given notice and an opportunity to be heard.
2. Whether the request for a preliminary injunction complied with Local Rule 65.1 when it was included only in the complaint's prayer for relief rather than filed as a separate document.

HOLDINGS

1. A preliminary injunction should not issue while the adverse parties have not received notice and a fair opportunity to present their version of the facts.
2. The request for a preliminary injunction did not comply with Local Rule 65.1 because it was included only in the complaint's prayer for relief rather than made in a separate document.

KEY QUOTATIONS

“The court may issue a preliminary injunction only on notice to the adverse party,”

“Even pro se litigants must follow both the Federal Rules of Civil Procedure and the local court rules.”

FACTUAL BACKGROUND

John Oliver Francois, a pretrial detainee at the Calcasieu Correctional Center, alleged that defendants refused to provide paper copies of his legal mail and instead scanned and digitally formatted it. He asserted that defendants could view the digital versions of privileged legal mail and that the policy caused him emotional distress. He sought an injunction prohibiting defendants from digitally scanning legal mail.

PROCEDURAL HISTORY

Francois filed multiple complaints and amended complaints asserting claims against numerous defendants. The case was referred to the magistrate judge under 28 U.S.C. § 636(b)(1)(B) for preliminary review, and the complaint was recently permitted to proceed in forma pauperis. Because the defendants had not been given notice and an opportunity to be heard, and because the request for preliminary injunctive relief was included only in the complaint's prayer rather than in a separate document as required by Local Rule 65.1, the magistrate judge recommended denial.
