FACTUAL BACKGROUND

Appellant's brief was due on March 25, 2019, following an earlier extension granted by the appellate court. Appellant filed another motion requesting thirty additional days to file the brief.

The appeal was pending in the Fourth Court of Appeals of Texas. After the court granted Appellant's first motion for an extension, his brief was due March 25, 2019; on that date, he filed a second motion seeking an additional thirty days.
