SUMMARY

The United States District Court for the Middle District of Florida granted SOS Mobile Medical Care, LLC’s motion for a preliminary injunction against Jason Gullledge. The court converted the previously issued temporary restraining order into a preliminary injunction, continued the defendant’s injunction, and directed the plaintiff to maintain a \$10,000 bond.

QUESTIONS PRESENTED

1. Whether the temporary restraining order should be converted into a preliminary injunction.
2. Whether Plaintiff was entitled to continued injunctive relief under the preliminary-injunction standard.

HOLDINGS

1. The temporary restraining order should be converted into a preliminary injunction and remain in effect until further order of the court.
2. Plaintiff's motion for a temporary restraining order and preliminary injunction was granted, and Defendant remained enjoined as detailed in the prior TRO.

“As set forth in the Court’s order granting the TRO, Dkt. 6, the Court finds that all factors necessary for the issuance of a preliminary injunction still weigh in Plaintiff’s favor.”

“The Temporary Restraining Order, Dkt. 6, is CONVERTED into a preliminary injunction and remains in effect until further ordered.”

FACTUAL BACKGROUND

SOS Mobile Medical Care, LLC filed a complaint against Jason Gulledge and sought emergency injunctive relief. The court initially granted an ex parte temporary restraining order, and Plaintiff properly served Gulledge. Gulledge did not appear or otherwise participate, and the court found that the factors supporting injunctive relief continued to favor Plaintiff.

PROCEDURAL HISTORY

Plaintiff filed its Complaint and motion for temporary restraining order and preliminary injunction on December 15, 2025. The court granted ex parte injunctive relief on December 16, 2025, Plaintiff served Defendant on December 19, 2025, and Defendant neither appeared nor took action. After a hearing scheduled for January 6, 2026, the court orally ruled that the TRO would be converted into a preliminary injunction and entered this written order.
