Timothy W. Wright, Jr. v. Virginia Department of Corrections, et al.

SUMMARY

The United States District Court for the Western District of Virginia denied without prejudice Timothy W. Wright, Jr.'s motion for a preliminary injunction in his 42 U.S.C. § 1983 action against the Virginia Department of Corrections and related officials. The court held that Wright had not clearly shown a likelihood of irreparable harm under the Winter preliminary-injunction standard, particularly because he acknowledged receiving some requested accommodations. The action concerns alleged failures to provide reasonable accommodations under the Americans with Disabilities Act.

PROCEDURAL POSTURE	A Virginia prisoner proceeding pro se filed a 42 U.S.C. § 1983 action against the Virginia Department of Corrections and prison officials in their official capacities, seeking injunctive relief under the Americans with Disabilities Act. The court treated a separately docketed filing as a motion for preliminary injunction.
STANDARD OF REVIEW	A preliminary injunction requires a clear showing that the movant is likely to succeed on the merits, likely to suffer irreparable harm absent preliminary relief, that the balance of equities tips in the movant's favor, and that an injunction is in the public interest. Each factor must be satisfied.

QUESTIONS PRESENTED

1. Whether Wright was entitled to a preliminary injunction requiring prison officials to provide requested ADA accommodations and other injunctive relief.
2. Whether Wright clearly demonstrated a likelihood of irreparable harm sufficient to warrant the extraordinary remedy of a preliminary injunction.

HOLDINGS

1. A party seeking a preliminary injunction must clearly show that he is likely to succeed on the merits, likely to suffer irreparable harm without preliminary relief, that the balance of equities tips in his favor, and that an injunction is in the public interest; each factor must be satisfied.
2. Wright was not entitled to a preliminary injunction because his pleading did not clearly show a likelihood of irreparable harm, particularly where he acknowledged receiving some accommodations and the requested relief would not affect the status quo.

KEY QUOTATIONS

“A preliminary injunction is an “extraordinary remedy intended to protect the status quo and prevent irreparable harm during the pendency of a lawsuit.””

“Each of these four factors must be satisfied.”

“Issuing a preliminary injunction based only on a possibility of irreparable harm is inconsistent with [the Supreme Court’s] characterization of injunctive relief as an extraordinary remedy that may only be awarded upon a clear showing that the plaintiff is entitled to relief.”

FACTUAL BACKGROUND

Wright alleged that prison officials knew he had spinal, gastrointestinal, mental-health, and hearing disabilities but had refused some requested ADA accommodations. He acknowledged, however, that defendants had provided some accommodations. He sought an order requiring medical and ADA officials to provide numerous accommodations, along with orders expunging a disciplinary offense and changing certain policies.

PROCEDURAL HISTORY

Wright filed a complaint titled Complaint and Motion for Injunction Relief, which was separately docketed as a Motion for Preliminary Injunction. The district court denied the motion without prejudice because the pleading did not satisfy the requirements for preliminary injunctive relief.
