FACTUAL BACKGROUND

The matter concerns the estate of Donald H. Williams, deceased. Tracy L. Dampier sought appellate review of a judgment entered by the Harris County Probate Court No. 3 in that estate proceeding. The document also

references a jury trial and motions for new trial, judgment notwithstanding the verdict, mistrial, and findings of fact and conclusions of law, but does not provide the underlying factual merits.

PROCEDURAL HISTORY

The underlying proceeding was in Harris County Probate Court No. 3, cause number 427,929. A judgment was entered in or about May 2015, and Dampier filed a notice of appeal on July 31, 2015. The document indicates that the appeal was directed to either the First or Fourteenth Court of Appeals in Harris County, Texas.
