SUMMARY

The United States District Court for the District of Nevada grants Humberto Perez’s motion for appointment of counsel in his pro se 28 U.S.C. § 2241 habeas petition. The order appoints the Federal Public Defender, directs service of the petition on the respondents and relevant government officials, and sets deadlines for a notice of appearance, response, and reply.

QUESTIONS PRESENTED

1. Whether counsel should be appointed for Perez in the interests of justice in connection with his § 2241 habeas petition.
2. Whether the petition should be served on the respondents and the respondents required to file a response.

HOLDINGS

1. The motion for appointment of counsel was granted because appointment was in the interests of justice in light of the complexities of the case.
2. Following preliminary review, the court directed that the petition be served on the respondents and required respondents' counsel to file a notice of appearance and a response by the dates specified in the order.

KEY QUOTATIONS

“Prisoners applying for habeas corpus relief are entitled to appointed counsel when the circumstances indicate that appointed counsel is necessary to prevent due process violations.” (at 1)

FACTUAL BACKGROUND

Humberto Perez is an immigration detainee who filed a pro se petition for a writ of habeas corpus under 28 U.S.C. § 2241. The court found that appointment of counsel was in the interests of justice, citing the complexities of the case, and ordered service of the petition on the federal and detention-related respondents.

PROCEDURAL HISTORY

The matter was initiated by Perez's pro se § 2241 habeas petition and motion for appointment of counsel.
