The evidence admitted at trial supports the trial court's findings that S.A. has not substantially complied with the case plan and that termination of S.A.'s parental rights is the least restrictive means to protect A.M.A. from harm. Furthermore, the record expressly contradicts S.A.'s claims that she was deprived of the right to participate in the trial and was not represented by counsel at trial. Accordingly, we affirm. See generally G.C. v. Dep't of Child. & Fams., 337 So. 3d 446, 448 (Fla. 3d DCA 2022). Affirmed. 2
