FACTUAL BACKGROUND

The document contains no substantive facts concerning the underlying criminal cases. It states only that appellant's attorney determined the appeals were frivolous and without merit and filed a corresponding brief.

PROCEDURAL HISTORY

The document concerns three criminal appeals identified by docket numbers 05-14-01031/01032/01033-CR. Appellant's attorney filed a brief asserting the appeals were frivolous and meritless, and the court gave appellant until February 9, 2015, to request access to the appellate record and file a pro se response.
