QUESTIONS PRESENTED

1. Whether the Supreme Court of Arkansas should appoint a special judge to preside over the respondent attorney's disbarment proceedings under section 13(A) of the Arkansas Supreme Court Procedures

Regulating Professional Conduct of Attorneys at Law.

HOLDINGS

1. Under section 13(A) of the Arkansas Supreme Court Procedures Regulating Professional Conduct of Attorneys at Law, the Supreme Court of Arkansas shall assign a special judge to preside over disbarment proceedings; accordingly, the court appointed the Honorable Randy Wright as special judge.

FACTUAL BACKGROUND

Robert M. Brech, executive director of the Arkansas Supreme Court Committee on Professional Conduct, filed a disbarment petition against Jacqueline Forsgren Mock. The Arkansas Supreme Court appointed the Honorable Randy Wright as special judge to hear the disbarment proceedings and prepare findings, conclusions, and a recommended sanction.

PROCEDURAL HISTORY

The matter came directly before the Supreme Court of Arkansas on a motion for appointment of a special judge in a pending attorney-disbarment proceeding. The court appointed the Honorable Randy Wright to preside over the proceedings and directed him to submit findings of fact, conclusions of law, and a recommended sanction; the Supreme Court stated that it would decide the matter after receiving those findings.

REMAND INSTRUCTIONS

The Honorable Randy Wright shall hear the disbarment matter, make findings of fact and conclusions of law, recommend an appropriate sanction, and file those materials with the Clerk of the Supreme Court. The Supreme Court will render a decision after receiving the special judge's findings.
