Kirby v. Philbert

SUMMARY

The Appellate Division, Second Department, affirmed an order denying the plaintiff's motion to strike the defendants' answer or impose other sanctions under CPLR 3124 and 3126 for failure to provide court-ordered discovery. The court held that there was no clear showing that the defendants' noncompliance was willful and contumacious, and upheld the trial court's decision to extend the discovery deadline.

QUESTIONS PRESENTED

1. Whether defendants' failure to comply with the court-ordered discovery warranted striking their answer, precluding them from supporting claims or defenses, or resolving all liability issues in plaintiff's favor under CPLR 3126.
2. Whether Supreme Court providently exercised its discretion by denying severe discovery sanctions while extending defendants' deadline to produce the demanded material.

HOLDINGS

1. Striking the defendants' answer, precluding them from supporting claims or defenses, or directing that liability issues be resolved in plaintiff's favor was not warranted because plaintiff failed to make a clear showing that defendants' noncompliance was willful and contumacious.

KEY QUOTATIONS

“Although public policy strongly favors that actions be resolved on the merits when possible, a court may resort to the drastic remedies of striking a pleading or precluding evidence upon a clear showing that a party's failure to comply with a disclosure order was the result of willful and contumacious conduct.” ([*1]-[*2])

“Here, there was no clear showing that the defendants' failure to comply with court-ordered discovery was willful and contumacious.” ([*2])

FACTUAL BACKGROUND

Plaintiff sought damages for personal injuries and served defendants with a post-deposition demand for disclosure. Although a compliance conference order required defendants to respond by June 24, 2023, plaintiff claimed defendants failed to produce the demanded material and sought severe discovery sanctions. Supreme Court denied the sanctions motion while extending the deadline for production.

PROCEDURAL HISTORY

In a personal-injury action, a May 15, 2023 compliance conference order directed defendants to respond to plaintiff's post-deposition disclosure demand by June 24, 2023. Supreme Court, Kings County, denied plaintiff's motion but directed defendants to produce the demanded material by June 5, 2024. The Appellate Division affirmed insofar as appealed from.

DISPOSITION

affirmed
